**4<sup>TH</sup> AMENDMENT TO SECOND AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF  
LIVING WELL FOUNDATION**

This 4<sup>th</sup> Amendment to the Second Amended and Restated Articles of Incorporation of Living Well Foundation, a Louisiana nonprofit corporation (the "Foundation"), is made by authority of the Foundation's sole member and its Board of Directors, as hereafter provided, and is executed in the Foundation's name by its Board Chair who certifies as follows:

1. In accordance with Section 237.A of the Louisiana Nonprofit Corporation Law and Article XI of the Second Amended and Restated Articles of Incorporation of the Foundation, as amended, (a) the Board of Directors of the Foundation, by the vote of three-fourths of the directors then in office (11 votes for, 0 votes against, 0 abstaining, 1 absent), at a regular meeting duly held on May 7, 2015 (the notice of which set forth the amendments made herein and which was either transmitted to the directors by first-class mail deposited not less than 30 days prior to the meeting, or such notice having been waived in a writing that set forth the amendments made herein), approved the amendments made herein, and (b) the Board of Commissioners of Hospital Service District No. 1 of the Parish of Ouachita (the "District"), which is the sole member of the Foundation, at a regular meeting duly held on May 19, 2015, the notice of which set forth the amendments made herein, and which meeting was held as provided by law for meetings of the Board of Commissioners, cast the sole vote for and approved the amendments made herein.

2. The following provisions of the Second Amended and Restated Articles of Incorporation of the Foundation, as amended, are now further amended as provided, and no other provisions of those Second Amended and Restated Articles of Incorporation, as amended are modified or changed in any manner.

3. Paragraph "(2)(b)" of Article VI of the Second Amended and Restated Articles of Incorporation, as amended, of the Foundation is hereby amended to read as follows:

"Article VI. Directors.

(1) General. \*\*\*

(2) Qualifications of Directors.


(a) \*\*\*

(b) Residency Qualifications. When originally elected, each District director must be a resident of the portion of Ouachita Parish that is west of the Ouachita River. However, a change in residence by a District director thereafter, to a place of residence that is outside that geographic area but which remains within the service area of the Foundation, shall not thereafter disqualify that District director from continuing to serve, nor disqualify that District director from being re-elected to further successive terms as a District director, but only during that period of time as the District director continues to maintain regular employment within the portion of Ouachita Parish that is west of the Ouachita river. Notwithstanding these provisions, at all times at least a majority of the District directors must be residents of the district. At least two of the three special Policy Jury directors must reside in the portion of Ouachita Parish that is west of the Ouachita River. The third special Police Jury director and any at-large Police Jury directors need not reside in the portion of Ouachita parish that is west of the Ouachita River, but must reside in Ouachita Parish."

IN WITNESS WHEREOF, pursuant to the direction of the Board of Directors of the Foundation, and with the approval of the Board of Commissioners of the District, which is the sole member of the Foundation, the Board Chair, who is an officer of the Foundation, has signed this 4<sup>th</sup> Amendment to the Second Amended and Restated Articles of Incorporation, as amended in the name of the Foundation on this 22<sup>nd</sup> day of May, 2015.


